Dear Mr. Alsop:

On September 18, 2008, the US Environmental Protection Agency (EPA) issued an Administrative Order (Order), Docket No. SDWA-08-2008-0106, ordering the Town of Pinesdale's compliance with the Safe Drinking Water Act (SWDA), 42 U.S.C. § 300f et seq., and its implementing regulations, the National Primary Drinking Water Regulations (NPDWRs) 40 C.F.R. part 141. Our records indicate the Town is in violation of the provision of the Order. Specifically:

## ORDER Paragraph 11 required:

Upon receipt of this Order, Respondent shall ensure that the turbidity of representative samples of the System's combined filter effluent at no time exceeds 1 NTU in at least 95% of the monthly samples. 40 C.F.R. §§ 141.73(d), 141.550 and 141.551.

Respondent failed to comply with Paragraph 11 of the Order when the turbidity of Respondent's produced water exceeded 1 Nephelometric Turbidity Unit (NTU) 22.58% of the time in March 2009 and 75% of the time in April 2009.

You must take immediate action to comply with the NPDWRs, 40 C.F.R. part 141, and the Order. EPA is considering additional enforcement action as a result of your noncompliance with the Order. Violating an Administrative Order may lead to (1) a penalty of up to \$37,500 per day per violation, and/or (2) a court injunction ordering you to comply.
