

**ORDER GRANTING JOINT MOTION FOR EXTENSION OF TIME**

By Motion dated July 15, 2009, the parties jointly moved for an extension of time to engage in the prehearing exchange.

The Motion is hereby, **GRANTED**, as set forth below:

Good cause exists for the granting of the Motion. The Motion indicates that the parties have reached a "complex" settlement involving a penalty, compliance, injunctive work as well as a supplemental environmental project, and they are actively working towards memorializing the terms thereof in a Consent Agreement and Final Order (CAFO). In that a hearing in this case has yet to be scheduled, no prejudice will result from a brief delay in the prehearing exchange process. Therefore, the Complainant shall have until **September 30, 2009** to submit its initial prehearing exchange; Respondent shall have until **November 1, 2009** to submit its prehearing exchange; and Complainant shall have until **November 22, 2009** to submit its rebuttal prehearing exchange.
