ORDER ON RESPONDENTS' MOTION REGARDING THE CROSS EXAMINATION OF MR. BEEDLE

Respondents have moved for leave to have two attorneys conduct cross-examination of Complainant's witness, Mr. Michael Beedle. (Motion Regarding the Cross Examination of Mr. Beedle ("Motion"), submitted May 30, 2012). Complainant responds that it does not disagree with the basis for Respondents' request, but requests that any granting of the Motion be conditional. (Response to Respondents' Motion Regarding the Cross Examination of Mr. Beedle ("Response"), filed June 4, 2012). Given the particular nature of Mr. Beedle's anticipated testimony (as both inspection and penalty witness) and the complexity of the material he is expected to cover, the Motion is GRANTED subject to the following conditions: attorneys for Respondents must divide the cross-examination of Mr. Beedle into two, rationally separated parts with no duplicative questioning; one attorney must follow the other at the completion of the other's cross-examination.
