Dear Mayor Taylor:

On January 22, 2008, the EPA issued an Administrative Order (Order) to the Town of Neihart (Town). On December 21, 2015, the Town submitted a plan and schedule, pursuant to paragraph 3 on page 7 of the Order, for completing System modifications. The EPA hereby approves this schedule as set forth below and, pursuant to paragraph 4 on page 7, it is incorporated into the Order.

The Town has requested an extension of interim milestones to accommodate changes in funding; however, the final completion date of December 31, 2016, remains in place. The Town was originally seeking funding for a larger project, which included water storage and improvements to the distribution system. The larger project was not funded; however, funding was secured to prioritize the building of the intake infrastructure, which should return the system to compliance with the Order.

2	Initiate Intake Project Design	January 31, 2016	Completed
3	Finalize Intake Project Design and submit streambed (310) permits application to the conservation district for construction.	June 30, 2016	
5	Final approval of streambed permits and initiate intake Project Construction	August 31, 2016	
6	Construction complete / New intake is online.	December 31, 2016	

Consistent with paragraph 4 of the Order section of the Administrative Order, the deadlines above are now an enforceable requirement of the Order.

Please note that the EPA expects this approved schedule to be met. Pursuant to paragraph 2 of the General Provisions section of the Order, the EPA is authorized to seek penalties if these deadlines are not met.
