ORDER GRANTING AN EXTENSION OF TIME TO FILE AN ANSWER TO THE COMPLAINT

On December 20, 2007, the Respondent filed a Motion Requesting an Extension of Time. In an attempt to ascertain certain facts about this matter, as well as whether Complainant concurs with Respondent's request, I sent an electronic message to both parties on January 3, 2008.

In his responses, one of Respondent's attorney claims that he made an earlier written motion for extension of time to answer, together with a request for an informal conference and a Notice of Appearance, and had a consultant contact Complainant's office in an attempt to schedule an informal conference, and requests this second extension of time to discuss settlement and hopefully avoid costly litigation.

Conversely, Complainant notes that the Respondent has already had over sixty (60) days to answer the complaint, made no meaningful effort to contact the Complainant, and has not shown good cause for a further extension.

Based on the information provided to the undersigned by the parties, including the fact that the undersigned was never served with any prior motions in this matter, the fact that this all happened around and during the holiday season, and the Respondent's professed desire to discuss settlement of this matter, all of which constitutes good cause shown under 40 CFR § 22.15, an extension through February 15, 2008 is hereby granted.
