REPORT OF STATUS CONFERENCE AND ORDER

The status teleconference in this matter was held on May 6, 2014. Participating were:

Introduction: The Presiding Officer requested that the parties' attorneys provide an update on efforts to resolve this matter.

Status: It appears that Respondent needs to gather specific details to update the SEP proposal and work out the final terms and conditions of the Consent Agreement and Final Order (CAFO). There has been a delay in gathering information on topography, soil, etc. but the Respondent has determined the number of residences that are going to be connected. Information will be updated when the connection of necessary residences are in the next phase. If the costs of these connections are in the lower range, than more residences can be connected. Respondent expects proposals from Engineer firms to complete the project will only be delayed two weeks and estimates that the SEP project can be completed in August of 2014.


