
**Motion to Amend Complaint**

The Administrator's Delegated Complainant, by Counsel, hereby moves to amend the Administrative Complaint, filed on May 16, 2007, by striking the penalty amount proposed in the Complaint -- that being \$46,200 -- and proposing in its place a penalty amount of \$29,700.

The original penalty of \$46,200 was mistakenly included in the original complaint, and a correction is necessary to accurately reflect the total penalty for all of the nine counts brought by the Complainant. This is the only change made to the original complaint. For purposes of agency economy, no separate amended complaint will be filed by the Complainant unless instructed to do so by the Administrative Law Judge.

Respondent has been informed, by telephone, and the Respondent has no objection to this motion.
