## ORDER GRANTING SECOND EXTENSION OF PREHEARING DEADLINES

A Prehearing Order issued in this matter set due dates for the parties to file their prehearing exchanges. Upon motion, the parties were granted an extension of time to file their prehearing exchanges. The due date for Complainant to file its Prehearing Exchange was March 12, 2012. On March 6, 2012, Complainant submitted a Status Report and Motion for Extension, seeking an additional two week extension of time for the parties to file their prehearing exchanges. The Motion states that a Consent Agreement to settle this matter was sent to Respondent for review and signature. The Motion states further that Respondent's counsel has no objection to the request.

The Rules provide that the presiding officer may grant an extension of time for filing any document "upon timely motion . . . , for good cause shown, and after consideration of prejudice to other parties." 40 C.F.R. § 22.7(b).

For good cause shown, Complainant's Motion for Extension of Time, dated March 6, 2012, is **GRANTED**. In the event the parties have not filed a fully executed Consent Agreement and Final Order settling this matter beforehand, Complainant shall file its Prehearing Exchange on or before March 29, 2012, Respondent shall file its Prehearing Exchange on or before April 19, 2012, and Complainant shall file its Rebuttal Prehearing Exchange on or before May 3, 2012.
