Subj: Emergency Administrative Order under Section 1431 of the Safe Drinking Water Act, Town of Browning Public Water System PWS ID #083090091 and Two Medicine Water Public Water System PWS ID #083090090, Docket No. SDWA-08-2024-0010

Dear Chairman Kipp Sr. and Mr. Galbreath:

Enclosed is an Emergency Administrative Order (Order) issued by the U.S. Environmental Protection Agency to the Two Medicine Water Company (TMWC) under section 1431 of the Safe Drinking Water Act (Act), 42 U.S.C. § 300i.

The EPA has determined that conditions exist at the Town of Browning and Two Medicine Water Public Water Systems (Systems) that may present an imminent and substantial endangerment to the persons served by the Town of Browning System. The EPA has made this determination based on notification from TMWC on January 3, 2024, that the Town of Browning System lost pressure.

Pursuant to the authority set forth in section 1431 of the Act, 42 U.S.C. § 300i, the EPA is authorized to take actions necessary to protect human health. The Order and its requirements are necessary to ensure adequate protection of public health.

The enclosed Order sets forth the actions that must be taken to ensure that the people served by the Systems are provided with safe drinking water. The Order requires the TMWC to, among other things, take the following actions: issue a boil water advisory and provide an alternate source of water until

notified by the EPA to discontinue; submit a plan and schedule to resolve the pressure loss; disinfect and flush the Town of Browning System; and take additional total coliform bacteria samples at the Town of Browning System.

The penalties for failing to comply are set forth in the Order.
