586. Count 536: Respondent failed to retain records necessary to demonstrate compliance with 40 C.F.R. Part 745, Subpart E for a period of 3 years following completion of the renovation at 22428 Bruce, Warren, Michigan.

587. Count 537: Respondent failed to retain records necessary to demonstrate compliance with 40 C.F.R. Part 745, Subpart E for a period of 3 years following completion of the renovation at 29900 Grand Oaks Drive, Warren, Michigan.

588. Count 538: Respondent failed to retain records necessary to demonstrate compliance with 40 C.F.R. Part 745, Subpart E for a period of 3 years following completion of

the renovation at 4121 Hillcrest, Warren, Michigan.

589. Count 539: Respondent failed to retain records necessary to demonstrate compliance with 40 C.F.R. Part 745, Subpart E for a period of 3 years following completion of the renovation at 25767 Patricia, Warren, Michigan.

590. Count 540: Respondent failed to retain records necessary to demonstrate compliance with 40 C.F.R. Part 745, Subpart E for a period of 3 years following completion of the renovation at 30956 Marrocco Drive, Warren, Michigan.

591. Count 541: Respondent failed to retain records necessary to demonstrate compliance with 40 C.F.R. Part 745, Subpart E for a period of 3 years following completion of the renovation at 5082 Lyons Circle South, Warren, Michigan.

592. Count 542: Respondent failed to retain records necessary to demonstrate compliance with 40 C.F.R. Part 745, Subpart E for a period of 3 years following completion of the renovation at 5614 Underwood, Detroit, Michigan.

593. Respondent's failure to retain records necessary to demonstrate compliance with 40 C.F.R. Part 745, Subpart E for a period of 3 years following completion of the renovations referred to in paragraphs 322 through 592, above, constitutes 271 violations of 40 C.F.R. § 745.86(a), promulgated under 15 U.S.C. § 2686 and § 2687.
