ORDER ON MOTION TO MODIFY BRIEFING SCHEDULE

An order setting forth the post-hearing briefing schedule in this matter was issued by the undersigned on May 10, 2012. On June 5, 2012, Complainant's Motion to Modify Briefing Schedule ("Motion" or "Mot.") was received. If Complainant files a reply brief, Respondents' reply brief, or a statement that no reply brief will be submitted, shall be filed on or before November 1, 2012.
