Summary

The EPA is providing notice of an opportunity for the public to comment on an Expedited Penalty Action and Consent Agreement (Consent Agreement). In the Consent Agreement, the EPA has alleged that the South Dakota Department of Transportation has violated a Clean Water Act National Pollutant Discharge Elimination System Construction General Permit for Stormwater Discharges from Construction Activities (Project-specific NPDES ID SDR101021) at a construction site located approximately 1.7 miles west of Lantry, South Dakota, within the exterior boundaries of the Cheyenne River Reservation.

Background

The EPA has alleged that the South Dakota Department of Transportation has failed to install required stormwater controls, failed to ensure all stormwater controls are maintained and remain in effective operating condition, and failed to properly manage stockpiles or land clearing debris piles composed of sediment and/or soil. Under the Consent Agreement, the South Dakota Department of Transportation has agreed to pay a civil administrative penalty of \$2,100 to resolve its civil penalty liability for these alleged violations. Before issuing an order approving the Consent Agreement and assessing this penalty, the EPA is providing an opportunity for the public to submit written comments and to participate in any hearing. Please see section 309(g) of the Clean Water Act, 33 U.S.C. § 1319(g), for more details.
