ORDER ON MOTION FOR LEAVE TO FILE JOINT STIPULATIONS

As you previously have been notified, I have been designated by the May 24, 2011, Order of the Chief Administrative Law Judge to preside in the above captioned matter. On July 26, 2011, Complainant submitted a Motion for Leave to File Joint Stipulations ("Motion") pursuant to 40 C.F.R. § 22.16(a). The attached Joint Stipulations, signed by both parties, sets out the basic history of the case and identifies four specific clarifications to the Complaint of record. See Jt. Stip. at 2 (changing citations to regulations, removing an improper date, correcting a building name, and correcting the Respondent's state of incorporation). The Motion also states that the parties have reached an agreement in principle. Because the proposed changes to the Complaint appear to be sufficiently ministerial in nature, the Motion is **GRANTED**. The modifications contemplated in the Joint Stipulations are hereby read into the Complaint.
