**Introduction**: The Presiding Officer established that the purpose of the teleconference was to assess the status of this matter.

**Status:** The Respondent's attorney claims that his client has no assets and no ongoing projects, and is therefore unable to pay the proposed penalty. The parties noted that the project which is the subject of the Agency's complaint was never finished. Complainant's attorney, while acknowledging that Respondent had forwarded certain tax returns to support its inability to pay claim, did complain of a delay in getting information from the Respondent, including a copy of the answer in this matter.

Respondent will put together relevant financial documentation to prove that it is facing severe financial constraints and forward the documentation to Complainant's attorney. Both parties agreed that it would be in the best interest of the parties to allow the Respondent additional time to compile and forward any necessary information, to allow Complainant to review that information, and to give the parties an opportunity to finalize, execute and file a CA/FO. Therefore, the parties requested that the status conference be continued, agreeing to a two month continuation.
