Good morning Spence,

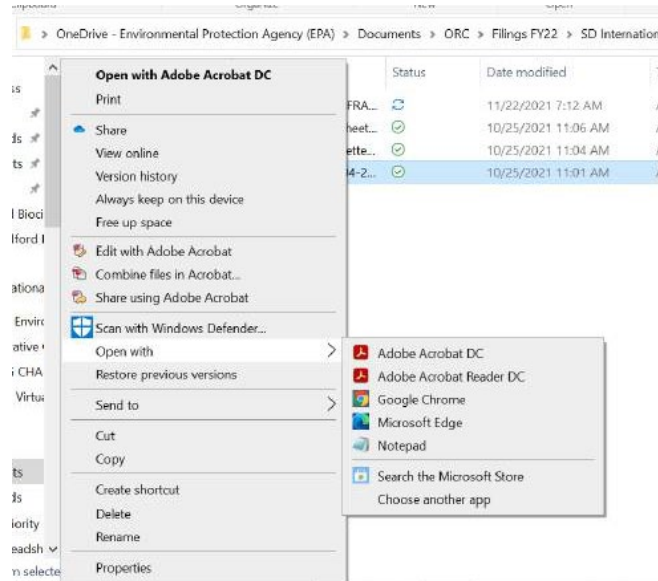
I was out of the office all of last week. Unfortunately, I can no longer access the original document.
