JOINT MOTION TO EXTEND THE STAY OF THE PROCEEDINGS

Counsel for the U.S. Environmental Protection Agency (EPA) Region 4 and Counsel for Russell Wise jointly request that the stay in the proceedings in the above-captioned matter be extended. On April 15, 2010, the Honorable Judge Biro had granted the parties April 15, 2010 Joint Motion for a Stay until June 15, 2010. At this time the parties are seeking an extension of the Stay until August 15th to ensure that all documents will be finalized after the public comment period closes. In support of this motion the Parties offer that Mr. Wise has signed both the Consent Decree and Final Order (CAFO) and the Consent Decree and Compliance Order (CACO). The CACO has been signed by EPA and is being scheduled for public notice on approximately June 24, 2010 with a 30 day comment period. The CAFO has been noticed and the comment period ends on July 11, 2010. Accordingly, the parties request 60 days to execute that document and file it in accordance with 40 CFR Part 22.

For the reasons set forth above, and in the interest of judicial economy, counsel for the Parties respectively request that the Joint Motion for a 60 day Stay of the Proceedings pending completion of the Consent Agreement and Final Order be granted.
