ORDER TO SUPPLEMENT RECORD

Background

Pursuant to Rule 22.17(a) of the Consolidated Rules of Practice, 40 C.F.R. § 22.17(a), Complainant filed a motion for default order in this proceeding on May 27, 2011, including a request for the assessment of a civil penalty in the amount of \$162,522. The motion is accompanied by a memorandum in support of motion for default order, which includes several exhibits. Rule 22.16(a)(4) states that any motion must be accompanied by, among others, any evidence relied upon.

Exhibit 4 to the memorandum in support is entitled Declaration of Wilfredo Rosado-Chaparro. Paragraph 47 of Exhibit 4 states as follows: "The penalty calculation worksheet for the alleged violations in this matter prepared by myself, with oversight from UST Program manager Margaret Stockdale, was delivered to the Respondent with the Complaint and is attached hereto." However, the referenced penalty calculation worksheet was not attached to the complaint or to the exhibit or any other document filed with the Regional Hearing Clerk.

Order

Based on the foregoing, it is therefore ORDERED, that Complainant shall, **no later than July 29, 2010**, file the penalty calculation worksheet referenced in the above-referenced Exhibit 4, and serve the document on Respondent.
