Dear Mr. Cummins:

On January 22, 2009, the US Environmental Protection Agency (EPA) issued an Administrative Order, Docket No. SDWA-08-2008-0098, ordering the Indian Ridge Water Conservancy District (the District), as owner and/or operator of the Indian Ridge Water System (the system), to comply with various regulations issued by EPA under the Safe Drinking Water Act (SDWA), 42 U.S.C. section 300f et seq.

Our records indicate that the District (Respondent) is in violation of the Administrative Order (the Order). Among other things, the Order included the following requirements (quoted from item 16 on page 3 of the Order):

Respondent shall comply with all total coliform routine sampling requirements. 40 C.F.R. § 141.21(b)(5). This requires that Respondent take no fewer than five routine total coliform bacteria samples during the next month after having one or more total coliform positive samples.

Respondent failed to take five routine samples in August 2009, taking these samples instead on September 28, 2009, following total coliform-positive results on July 28, 2009.

We also remind you that the District is required to issue a public notice for the violation detailed above within twelve months of occurrence, that is, by September 28, 2010.

EPA may consider additional enforcement action as a result of the non-compliance with the Order. Violating an Administrative Order may lead to (1) a penalty of up to \$37,500 per day per violation of the Order, and/or (2) a court injunction ordering compliance.
