

**SUBSTITUTE MOTION FOR EXTENSION OF TIME TO FILE ANSWER**

Pursuant to 40 CFR §22.16, Private Reserve Properties, LLC (“Respondent”) hereby moves for an extension of time up to and including November 30, 2012 to file its Answer to the Administrative Complaint (“Complaint”) in the above-referenced matter. As grounds for the requested relief, Respondent states that it expects to reach an agreement with the Environmental Protection Agency (“EPA”) on the overall settlement amount by the end of this week. Thereafter, Respondent and EPA will need an additional period of time to work together on the details of Respondent’s proposed supplemental environmental project and memorialize the conceptual settlement in a written consent agreement. Respondent expects to be able to complete these tasks by the end of November. EPA has no objection to the requested extension.
