

Pursuant to the Presiding Officer's Prehearing Order of April 15, 2008, Complainant is hereby providing a Status Report for the above-referenced matter. Counsel for Complainant has discussed the content of this Status Report with Respondent's attorney, Mr. Robert Hash, who indicated his concurrence.

On April 21, 2008, U.S. EPA provided a proposed Consent Agreement and Final Order (CAFO) to Respondent's counsel for review. U.S. EPA requested initial comments on the CAFO by Monday, April 28, 2008. Although Mr. Hash has not yet been able to provide comments, U.S. EPA anticipates that Respondent will provide any comments regarding the CAFO in a timely manner and that the parties will then be in a position to finalize the settlement by the May 23, 2008 date required in the Prehearing Order.
