ORDER EXTENDING PREHEARING DEADLINES

A Prehearing Order was issued in this matter on December 22, 2011, directing the parties to engage in a series of prehearing information exchanges and establishing deadlines by which those exchanges were to take place. On January 20, 2012, Complainant filed a Status Report and Motion for Extension of the prehearing deadlines ("Motion"). In the Motion, Complainant states that Respondent's counsel has submitted a proposal for a Supplemental Environmental Project that Respondent wishes to have evaluated for the purpose of settlement. Complainant requests that the deadlines set forth on the Prehearing Order be extended by thirty days to allow Complainant to evaluate Respondent's proposal. Complainant states that Respondent's counsel does not object to this request.

The unopposed Motion is hereby GRANTED for good cause in accordance with 40 C.F.R. § 22.7(b), and the deadlines set forth in the Prehearing Order dated December 22, 2011, are extended by thirty days. Accordingly, if the parties are unable to file a fully-executed Consent Agreement and Final Order, they must prepare for hearing and shall strictly comply with the requirements of the Prehearing Order in accordance with the revised deadlines set forth herein:

- March 12, 2012 Complainant's Initial Prehearing Exchange
April 2, 2012 Respondent's Prehearing Exchange
April 16, 2012 Complainant's Rebuttal Prehearing Exchange


