EXPEDITED SETTLEMENT AGREEMENT AND FINAL ORDER

- The U.S. Environmental Protection Agency, Region 6 ("EPA") is authorized to enter into this Expedited Settlement Agreement ("Agreement") pursuant to Section 3008 of the Resource Conservation and Recovery Act ("RCRA"), 42 U.S.C. § 6928 and 40 C.F.R. § 22.13(b).
- 2. Pursuant to Section 3008(a)(2) of RCRA, 42 U.S.C. § 6928(a)(2), EPA has provided notice to the state of Texas of this action.
- 3. Lighting Resources ("Respondent") is the owner or operator of the facility located at 101 E Bowie St Fort Worth, Texas 76110-4216 (the "Facility"). The EPA alleges that Respondent violated the following requirements of RCRA and the EPA approved and authorized Texas hazardous waste management program:
 - a. 30 TEX. ADMIN. CODE § 335.152(a)(4) and 40 C.F.R. § 264.71(a)(2)(v) require that manifests be submitted to EPA's e-Manifest system within 30 days of the date the waste was delivered. On 192 occasions from 2020 to 2023, Respondent failed to submit manifests to the e-Manifest system for purposes of data entry within 30 days of the date of delivery, in violation of 30 TEX. ADMIN. CODE § 335.152(a)(4) and 40 C.F.R. § 264.71(a)(2)(v).
 - 5. 30 TEX. ADMIN. CODE § 335.152(a)(22) and 40 C.F.R. § 265.1311(b)(2) require that manifests be certified at the time of submission. On 1 occasion from 2020 to 2023, Respondent failed to certify manifests

submitted to the e-Manifest system in violation of 30 TEX. ADMIN. CODE § 335.152(a)(22) and 40 C.F.R. § 265.1311(b)(2).

4. The EPA and Respondent agree that settlement of this matter for a civil penalty of \$5,000 dollars is in the public interest. Respondent certifies that it has provided payment for the full civil penalty amount, and that such payment identified Respondent by name and docket number, was made by certified or cashier's check made payable to the "United States Treasury", and sent to:

5. In signing this Agreement, Respondent: (a) admits that Respondent is subject to RCRA and the implementing regulations; (b) admits that the EPA has jurisdiction over Respondent and Respondent's conduct as alleged herein; (c) neither admits nor denies the factual allegations contained herein; (d) consents to the assessment of this penalty; and (e) waives the opportunity for a hearing to contest any issue of fact or law set forth herein; (f)

waives its right to appeal the Final Order accompanying this Agreement pursuant to Section 3008(b) of RCRA, 42 U.S.C. § 6928(b); and (g) consents to electronic service of the filed ESA.

- 6. By signature below, Respondent certifies, subject to civil and criminal penalties for making a false submission to the United States Government, that Respondent: (a) has corrected the alleged violations, as applicable, and has submitted true and accurate documentation of such correction along with this Agreement; (b) has submitted payment of the civil penalty as set forth below; and (c) has submitted a true and accurate proof of payment of the civil penalty along with this Agreement.
- 7. The undersigned representative of Respondent certifies that he or she is fully authorized to enter the terms and conditions of this Expedited Settlement Agreement and Final Order and to execute and legally bind Respondent to it. Upon the effective date of this Agreement, payment of the civil penalty shall constitute full settlement of the civil claims alleged herein.
- 8. Full payment of the civil penalty shall only resolve Respondent's liability for federal civil penalties for the violations alleged herein. EPA reserves its rights to take enforcement action for any other past, present, or future violations of RCRA, any other federal statute or regulation, or this Agreement.
 - Each party shall bear its own costs and fees, if any.
- The Agreement is binding on the parties signing below, and in accordance with
 C.F.R. § 22.31(b), is effective upon filing.
- 11. This Agreement authorized by the EPA's execution of the Final Order attached hereto constitutes a final order under 40 C.F.R. Part 22.

12. The penalty specified herein shall represent civil penalties assessed by EPA and shall not be deductible for purposes of Federal, State, and local taxes.

13. The EPA and Respondent agree to the use of electronic signatures for this matter pursuant to 40 C.F.R. § 22.6. The EPA and Respondent further agree to electronic service of this Agreement by email to the following:

Nothing in this Final Order shall be construed to waive, extinguish, or otherwise affect Respondents' (or its officers, agents, servants, employees, successors, or assigns) obligation to comply with all applicable federal, state, and local statutes and regulations, including the regulations that were the subject of this action.
