NOTICE OF HEARING


The Parties have confirmed availability for a hearing commencing at **9:30 a.m. on Tuesday, June 2, 2009** and continuing, as necessary, through Friday, June 5, 2009 in Chicago, IL.

In the event there is not a courtroom available in Chicago, IL, the regional hearing clerk is to secure a courtroom in the vicinity of Chicago, IL. **Accordingly, the regional hearing clerk is directed to determine the availability of a courtroom for the dates above and to advise the Court as to the arrangements. A subsequent notice will advise the parties of the courtroom location.**

No dispositive motions may be filed after March 31, 2009. In addition to complying with the procedural rules requirements regarding filing, motions are also to be filed by facsimile with the Court.

In addition to the paper filing requirements for motions and post-hearing briefs, as set forth at 40 C.F.R § 22.26, the parties are to submit, to the court only, a CD version of such filings and replies thereto. The parties are advised that the purpose behind this requirement is to make it possible for the Court to quote liberally from those documents in creating its orders and decisions. Please do not have the disk version of the document encoded or otherwise adorned with boxes which make it difficult or impossible to cut and paste from those submissions, as that defeats the purpose of the requirement.

The parties are directed to confer and acting in good faith, stipulate to those facts which are not genuinely in dispute, so that the hearing may be more efficiently conducted. The parties are reminded that, pursuant to the Consolidated Rules of Practice, at the hearing an original and one copy of each exhibit shall be filed with the undersigned Presiding Judge for the record (an exhibit notebook binder is appreciated) and a copy furnished to each party. A true copy of any exhibit may be substituted for the original. **Please be sure that copies are legible with printing on one side only.**


