Dear Ms. Brown:

On November 14, 2018, the U.S. Environmental Protection Agency issued an Administrative Order (Order), Docket No. SDWA-08-2019-0004, directing Leisure Valley, Inc., referenced in the Order as the Respondent, as owner/operator of the Star Valley RV Park Public Water System, to comply with various drinking water regulations issued by the EPA under the Safe Drinking Water Act (SDWA), 42 U.S.C. section 300f et seq.

Our records indicate that the Respondent is in violation of the Order. Among other things, the Order included the following requirement (summarized from item 15 on page 3 of the Order), which has not been fulfilled:

• Within 30 days of receipt of this Order, Respondent shall (1) prepare an annual CCR for the System covering the years 2013, 2014, and 2017 and distribute the CCR to the System's customers and the EPA and (2) certify to the EPA that these CCRs and the 2016 CCR have been distributed to the System's customers and that its information is correct and consistent with monitoring data previously provided to the EPA. Thereafter, Respondent shall prepare and distribute annual CCRs and provide certifications as required by 40 C.F.R. §§ 141.151-141.155.

The EPA has not received the annual CCR covering the year 2017 identified in the Order. Additionally, the EPA has not received the annual CCR covering 2018. Respondent must distribute the CCRs covering 2016, 2017 and 2018 to the System's customers, submit copies of the CCRs to the EPA, and provide certifications of CCR distribution to the EPA by November 1, 2019.

The EPA is considering additional enforcement action as a result of non-compliance with the Order. Violating the Order may lead to (1) a penalty of up to \$57,317 per day per violation of the Order, and/or (2) a court injunction ordering compliance.
