
On July 2, 2009, Complainant filed with the Region 5 Hearing Clerk Complainant's Motion for Accelerated Decision on Derivative Liability (Motion). Accompanying that motion were Complainant's Memorandum in Support of Motion for Accelerated Decision on Derivative Liability (Memorandum), and attachments. Some attachments contain confidential business information (CBI) of Respondents, and portions of the Memorandum contain references to those CBI attachments. Consequently, Complainant configured its filing in two separate binders.

One filed binder contained a copy of the Memorandum, including CBI material referenced therein. The second binder contained an edition of the Memorandum with CBI referenced material deleted. Attached to the CBI deleted edition of the Memorandum were only those attachments which did not contain CBI. Motivated by a desire to save on the Region 5 Hearing Clerk's limited CBI storage space, attached to the CBI included edition of the Memorandum were only those attachments which did contain CBI.
