The U.S. Environmental Protection Agency (EPA) Region 2 is in receipt of Parsco, Inc.'s penalty payment of \$2,820, the signed Expedited Settlement Agreement, and the documentation that the USTs at the above referenced facility are now in compliance. By signing the Expedited Settlement Agreement, you have agreed to the terms of the Expedited Settlement Agreement and Final Order and have certified that a violation cited in the proposed Expedited Settlement Agreement was corrected.

Enclosed you will find a copy of the Expedited Settlement Agreement and Final Order issued by EPA. EPA has approved the Expedited Settlement Agreement based on your signed certification and supporting compliance documentation.

Note, as per the Energy Act of 2005, EPA and or the State are required to inspect UST facilities every 3 years. If EPA finds federal UST violations at future inspections, or from any other information obtained by EPA, such findings would be Parsco's second violation of Federal UST regulations. A second offense may result in a civil or judicial action which can include seeking penalties of up to \$24,730 per UST system per day of violation.
