**ORDER**


This matter is governed by the Consolidated Rules of Practice at 40 C.F.R. Part 22. Complainant filed this action pursuant to the Toxic Substances Control Act, 15 U.S. C. § 2615(a) on June 20, 2011, and Respondent received the Complaint on June 22, 2011. Pursuant to 40 C.F.R. 22.15(a), the Answer was due on July 22, 2011. On July 28, 2011, Respondent filed a Motion for Extension of Time to Answer requesting an additional 30 days to file an Answer because it believes the parties are likely to resolve this matter by settlement. (According to 40 C.F.R. § 22.5(a), a document is filed when it is received by the appropriate Clerk.)

In a conference call with both Parties conducted on August 2, 2011, counsel for Complainant confirmed that settlement discussions are ongoing and that Complainant has no objection to Respondent's motion.

Accordingly, pursuant to 40 C.F.R. § 22.7(b) and for good cause shown, Respondent's Motion for Extension of Time to Answer filed by Respondents is hereby GRANTED. Respondents shall have until **September 2, 2011**, to file an answer or otherwise plead in this matter.


