Dear Mr. Mirsky:

On September 19, 2011, a Final Order ratifying a Consent Agreement (collectively, the "CAFO") entered into by the Director of the Land and Chemicals Division of the U.S. Environmental Protection Agency, Region III ("EPA" or the "Agency"), and Respondents 1500 Walnut Enterprises, LLC and SSH Management, LLC was issued by the Agency. That CAFO, EPA Docket No. TSCA-03-2011-0288, simultaneously initiated and resolved alleged violations by the Respondents of Section 15 ("Prohibited acts") of the Toxic Substances Control Act ("TSCA"), 15 U.S.C. § 2614, and of the regulations implementing Section 6(e) ("Polychlorinated biphenyls") of TSCA, 15 U.S.C. § 2605(e), as set forth at 40 C.F.R. Part 761. Such statutory and regulatory provisions are enforceable pursuant to Sections 15 and 16 of TSCA, 15 U.S.C. §§ 2614 and 2615.

Under the CAFO, Respondents agreed to pay a \$20,000.00 civil penalty within 30 days of the CAFO's effective date and to spend at least \$38,600.00 in the performance and timely completion of a polychlorinated biphenyl ("PCB") Transformer removal Supplemental Environmental Project ("SEP").

I am advised that on or about September 28, 2011, Respondents paid the required \$20,000.00 civil penalty. I am further advised that by letter dated December 11, 2012, EPA provided Respondents with written notice of the Agency's determination that the Respondents had paid all civil penalty amounts due under the terms of the CAFO and had complied fully with the SEP requirements and with all additional requirements of the CAFO. Therefore, on behalf of the Agency and in accordance with Paragraph 69 of the Consent Agreement, I hereby issue this Letter of Remittance to the Respondents.
