## OLD COLONY COMPANY'S RESPONSE TO COMPLAINANT, ENVIRONMENTAL <u>PROTECTION AGENCY'S TSCA COMPLAINT</u>

## I. INTRODUCTION

The following Answer from Old Colony Company, the Respondent, is in response to the Toxic Substance Control Act ("TSCA"), 15 U.S.C. § 2615(a), Complaint received from the Environmental Protection Agency ("EPA"), the Complainant, dated September 15, 2008. The Respondent has responded to each of the Complainant's allegations relating to the 25 sales agreements associated with the 24 housing units at issue in this case.

## II. JURISDICTION

1. Paragraph 1 of the Complainant's Complaint contains legal conclusions to which no response is required.

### **III. DEFINITIONS AND REGULATORY REQUIREMENTS**

2. Respondent admits to the language in Paragraphs 2 through 17 of the Complaint as a reiteration of existing law.

# IV. FINDINGS OF FACT AND CONCLUSIONS OF LAW

3. Respondent is without information sufficient to affirm or deny the assertions contained in Paragraphs 18 through 22.

4. Respondent admits the assertions in Paragraphs 23 through 119 except for a portion of Paragraph 63. The 105 Sunny Brook Drive, St. Albans, WV sales transaction #10 was a sale of target housing at foreclosure.

## V. VIOLATIONS

5. Respondent denies the assertions in Paragraphs 120 through 147 of the Complaint.

#### VI. HEARING REQUEST

6. Respondent respectfully requests a hearing in this matter.

#### VII. AFFIRMATIVE DEFENSES

7. Respondent submits that some or all of Complainant's claims may be barred, in whole or in part, by application of the following:

A. Lack of jurisdiction; andB. Lack of standing.
