JOINT MOTION FOR EXTENSION OF TIME TO FILE AN ANSWER

Pursuant to Sections 22.7 and 22.16 of Title 40 of the Code of Federal Regulations,

Complainant and Respondent jointly request a 6-month extension of time to file an Answer to the

Complaint in the above-captioned matter through and including August 8, 2011.

The Complaint was served by overnight delivery on October 6, 2010, thus the original due date for the Answer was November 8, 2010. Complainant and Respondent jointly requested and were granted a 3-month extension of time to file an Answer through and including February 8, 2011.

Complainant and Respondent have agreed to discuss settlement of this matter as an alternative to an administrative hearing. Respondent previously submitted financial statements and recently submitted tax returns for Complainant's consideration of the impact of a penalty on Respondent's ability to continue in business. This ability to pay consideration is required under FIFRA Section 14(a)(4), 7 U.S.C. § 136l(a)(4). Due to budget constraints, Complainant has been unable to utilize an outside contractor for the financial analysis. Complainant is presently limited to performing the financial analysis in-house. Complainant encountered difficulty analyzing the

financial statements and thus requested and received the tax returns from Respondent.

Complainant is in the process of attempting to run ABEL, the computer model used to evaluate a corporation's ability to afford compliance costs or civil penalties. Therefore, an additional extension of time to Answer the Complaint is required.
