Dear Mr. Hongo:

This is an Addendum to the Emergency Administrative Order (Order) issued to you on June 9, 2023. The purpose of this letter is to approve your July 5, 2023, schedule (Schedule) for preventing future *E. coli* contamination at the Bunkhouse Bar and Grill Public Water System (System). The Schedule is hereby incorporated into the Order pursuant to paragraph 20 of the Order. Each milestone and deadline specified below is an enforceable provision of the Order.

Email each result to the EPA immediately upon receipt of the analysis from the laboratory. Collect weekly "special" total coliform samples (one sample per week).	Within 24 hours after the notification referenced in Row #11 has been completed. Beginning on the first date, when no chlorine residual is detected/chlorine levels returned to normal, following disinfection and flushing and continuing until receiving written notification from the EPA that consecutive daily samples may be discontinued. The first week after being notified by the EPA that consecutive daily samples may be discontinued and continuing until receiving written notification from the EPA.

Per paragraph 17 of the Order, you are required to provide the public with an alternative potable water supply that is available at no cost to all users of the System as needed for drinking, hand washing, cooking, maintaining oral hygiene, and dish washing. You are required to provide at least two liters of potable water daily per person at a central location that is accessible to all persons served by the System. The alternate water supply shall be made available until you receive written notification from the EPA that it is no longer necessary to supply it.

The EPA is authorized to seek penalties if these deadlines are not met. If you have a reasonable basis to believe you may be unable to meet any deadline in the Schedule, you must notify the EPA well in advance of the scheduled deadline to request an extension. The EPA may, in its discretion, consider granting an extension.
