As detailed in the Rules of Practice at 40 C.F.R. § 22.16, "a party's response to any written motion must be filed within 15 days after service of such motion." 40 C.F.R. § 22.16(b). Further, "any party who fails to respond within the designated period waives any objection to the granting of this motion." <u>Id</u>. As Complainant's motions were served on Respondent by U.S. Mail, an additional five days are accorded to file a response, for a total of twenty days after Complainant's January 17<sup>th</sup> filing. 40 C.F.R. § 22.7(c). As a result, Respondent has until <u>February 6, 2006</u> to respond to Complainant's motions.

Should Respondent fail to understand either the nature of this order or the motions currently before this tribunal, Respondent is encouraged to schedule a conference call with Complainant and the Presiding Officer as soon as possible. So ordered.
