ASSENTED-TO MOTION FOR FOURTH EXTENSION OF TIME FOR RESPONDENT TO FILE ANSWER AND REQUEST HEARING

Pursuant to 40 C.F.R. § 22.7(b); C.E. Bradley Laboratories, Inc. ("Respondent") respectfully requests a short fourth extension of time of two additional calendar days (i.e., until March 2, 2016) for Respondent to file a written Answer and a Request for Hearing to the Administrative Complaint filed on October 1, 2015 by the EPA Region I Office of Environmental Stewardship's Legal Enforcement Division ("Complainant"). As grounds for this motion, the Respondent states as follows:

- 1. On October 1, 2015, the Complainant filed its Administrative Complaint in this action.
- 2. On October 2, 2015, Complainant served Respondent's President, Rashed Kanaan, with a copy of the Administrative Complaint and related case-opening papers. Without an extension of time, Respondent's Answer and Request for Hearing would have been due no later than November 2, 2015.¹
- On October 27, 2015, Respondent filed an assented-to motion for extension of time to file
 Respondent's answer and to request a hearing, seeking an extension of time until

Respondent's Answer and Request for Hearing, absent extension, would have been due thirty (30) days following service of the complaint. Because the thirtieth day fell on Sunday, November 1, the actual response date would have been Monday, November 2, 2015, pursuant to 40 C.F.R. § 22.7(a).

- December 15, 2015 to file Respondent's Answer and Request for Hearing. That motion was granted.
- 4. On December 8, 2015, Respondent filed an assented-to motion for second extension of time to file Respondent's answer and to request a hearing, seeking an extension until January 29, 2016. That motion was granted.
- 5. On January 22, 2016, Respondent filed an assented-to motion for third extension of time to file Respondent's answer and to request a hearing, seeking an extension until February 29, 2016. That motion was granted on January 28, 2016.²
- 6. Counsel for Complainant and Respondent (collectively, the "Parties") have spoken, and have expressed a shared interest in principle to pursuing discussions about achieving an expeditious settlement of this matter. Since the filing of the last motion for extension of time, the Parties have continued to share information and discuss the allegations set forth in the Administrative Complaint.
- 7. An extension until March 2, 2016 is anticipated to provide the Respondent with sufficient time to review and finalize its answer and request for hearing with its counsel before filing.
- 8. Despite the forthcoming filing of Respondent's answer, defenses and request for hearing, the Parties still wish to engage in further meaningful settlement discussions.
- 9. Counsel for Complainant, Andrea Simpson, has been contacted regarding Respondent's request, and has noted her assent to this modest fourth extension of time.
