This letter is to inform you of the decision of the United States Environmental Protection Agency (EPA) to close the Administrative Order ("Order"), Docket No. SDWA-08-2007-0016 issued to Emmanuel Lutheran Church of Shepherd on March 23, 2007. EPA has determined that Emmanuel Lutheran Church of Shepherd has complied with the requirements of the Administrative Order and therefore we will close the Order at this time.

Please be aware that Emmanuel Lutheran Church of Shepherd is still required to comply with the National Primary Drinking Water Regulations (NPDWRs), 40 C.F.R. Part 141. Violation of the NPDWRs or an administrative order may result in a court-imposed injunction and/or penalties of up to \$32,500 per day of violation.
