ADMINISTRATIVE ORDER ON CONSENT TO ADDRESS

CLEAN WATER ACT VIOLATIONS

Dear Mr. Goodwin:

Attached is the executed Administrative Order on Consent ("AOC") concerning violations of the Clean Water Act ("CWA"), as amended, 33 U.S.C. § 1251, et seq. The United States Environmental Protection Agency ("EPA") is issuing this AOC to you ("Respondent") under the authority of Section 309(a) of the Clean Water Act ("CWA" or "Act"), 33 U.S.C. §1319(a), to address violations at the property located near Dixie Winds Lane, Bremo Bluff, Virginia 23022 ("Site"), which is owned and operated by the Respondent. The AOC requires the Respondent to submit certain documents to EPA and implement certain activities in order to address violations of Section 301(a) of the CWA, 33 U.S.C. § 1311(a), and comply with Section 404 of the CWA, 33 U.S.C. § 1344.

Specifically, the Order in the AOC requires the Respondent to:

- (1) Submit a Temporary Stabilization Plan to EPA for review and approval, which addresses all unstabilized areas on the Site and proposes measures to prevent the migration/erosion of soil or sediment-laden water into all receiving waters;
- (2) Submit a detailed Site Restoration and Mitigation Plan and schedule for implementation ("Restoration Plan") to EPA for review and approval, which addresses site conditions;
- (3) Implement the Restoration Plan, following EPA's approval of the Plan;
- (4) Submit a certification to EPA, stating that the work described in the approved Restoration Plan has been completed, no later than twenty (20) calendar days after completion of the restoration activities; and
- (5) Monitor the restored area at the Site for a period of no less than five (5) years to ensure the objective of restoring impacted aquatic resources.

Please note that the effective date of this AOC is today, the date of your receipt of this document.
