Dear Mr. Dellheim:

Attached is an Administrative Compliance Order on Consent ("Consent Order") that the United States Environmental Protection Agency ("EPA") is issuing to Adell Polymers, Inc. ("API"). EPA is issuing this Consent Order to API pursuant to its authority under Section 113(a) of the Clean Air Act ("CAA" or the "Act"), 42 U.S.C. § 7413(a), for API's alleged violation of CAA Section 113(a)(1), 42 U.S.C. § 7413(a)(1), and requirements of the federally enforceable WV SIP, at its thermoplastic compound and resin manufacturing plant located at 115 Potomac Avenue, Petersburg, West Virginia 26847(the "Facility"). The attached Consent Order is effective immediately upon your receipt and requires immediate compliance with all of the requirements listed in the Consent Order. Any violation of this Consent Order is subject to civil penalties under Section 113(b)(2) and (d)(1) of the Act, 42 U.S.C. §§ 7413(b)(2) and 7413(d)(1).

As noted above, the attached Consent Order takes effect immediately upon your receipt, whereupon it will remain in effect unless and until revoked, terminated, suspended, or modified, in writing, by EPA.
