Attached (in .pdf format) please find the time-stamped Consent Agreement and Final Order in the above-captioned matter. The Consent Agreement and Final Order resolve alleged violations of Section 203(a)(3)(A) and (B) of the Clean Air Act, 42 U.S.C. §§ 7522(a)(3)(A) and (B), and the implementing regulations found at 40 C.F.R. §§ 1068.101(b)(1) and (2), regarding prohibitions against the manufacture, sale, offering to sell, or installation of aftermarket parts, components or defeat devices, alleged against Tony's Corvette Shop, Inc., The Collector Car Museum, LLC and Best Corvette Parts LLC ("Respondents").

Respondents must timely pay the agreed civil penalty in accordance with the terms and provisions specified in the Consent Agreement. The case name and case docket number should be noted on Respondents' payment and a copy of the associated check or electronic transfer instrument and/or receipt should be sent, via e-mail, simultaneously to Sr. Assistant Regional Counsel A.J.
