Dear Ms. Landis:

On January 23rd, 2023, the U.S. Environmental Protection Agency, Region 7 (EPA) conducted an inspection of the Red Star Yeast Co. facility located at 950 60th Ave S.W. in Cedar Rapids, Iowa to determine compliance with the requirements of the Resource Conservation and Recovery Act (RCRA). The inspection identified certain alleged violations of RCRA. Pursuant to EPA's prefiling letter transmitted July 5, 2023, our settlement discussions via telephone on August 2, 2023, and your email dated August 2, 2023, EPA proposes settling the alleged violations and offered Red Star Yeast the opportunity to propose a Supplemental Environmental Project (SEP) as part of the final settlement of this matter.

In response to the foregoing, Red Star Yeast is proposing the following SEP. The Cedar Rapids Fire Department (CRFD) has a Hazardous Materials team that would respond to hazardous waste incidents at the Cedar Rapids facility, including potential spills from the containers or tanks identified as part of EPA's inspection. CRFD is interested in participating in the SEP. CRFD leadership personnel have prepared the below list of equipment that would aid in their response to a hazardous waste or other chemical incident, including potential spills or releases. The table below details the equipment request, quantity, unit cost, and total cost. Red Star proposes acquiring and providing this equipment to CRFD for the SEP.

Based on Red Star's review of the EPA SEP Policy 2015 Update,¹ Red Star believes that the proposed SEP meets applicable requirements and guidelines, including having a sufficient nexus and relationship between the alleged violations and the proposed SEP. Red Star also is willing to work cooperatively with EPA and the proposed SEP recipient, CRFD, to ensure that any other SEP requirements and certifications are satisfied. For successful implementation of the SEP, Red Star respectfully requests a reduction of the total proposed penalty amount in any settlement with EPA by 80% of the total SEP costs, which is in line with the EPA SEP Policy 2015 Update.

Based on the foregoing, Red Star Yeast Co. submits this SEP proposal to EPA for its review and approval.
