
JOINT REQUEST FOR EXTENSION OF
ALTERNATIVE DISPUTE RESOLUTION PROCESS

Pursuant to the Order Initiating Alternative Dispute Resolution (“ADR”) process entered June 26, 2007, in this matter, the Parties hereby respectfully request an extension of the ADR process for 60 days beginning August 27, 2007, and ending October 26, 2007.

1. To date, the Parties and Judge Spencer T. Nissen, the designated neutral, have held two conferences in this matter, and the Parties have exchanged requested information to facilitate further discussion and possibly settlement.
2. On or about August 28, 2007, a letter status report was submitted by Complainant on behalf of the Parties to Judge Nissen.
3. On or about August 31, 2007, the Parties completed an exchange of settlement offers, and the Defendant proposed performing a supplemental environmental project (“SEP”) as part of its offer.
4. As soon as the Parties’ individual schedules permit, the Parties plan to conference and further discuss the Defendant’s SEP proposal and also negotiate further.
5. The Parties are motivated to achieve settlement of this matter and request this extension in order to have additional time to resolve remaining issues.

The Parties hereby respectfully request a 60-day extension of the ADR process, as indicated above, in order to facilitate settlement of this matter.
