COMES NOW, Amy Swanson, Enforcement Attorney for Complainant United States Environmental Protection Agency, Region 8, and moves on behalf of the Complainant for a one week extension of time to file Complainant's Supplemental Prehearing Exchange or, alternatively, a Status Report if Complainant elects not to supplement its Prehearing Exchange. Pursuant to the Regional Judicial Officer's Status Order of May 30, 2012, the Complainant currently is ordered to file its supplement on or before June 22, 2012. The Complainant specifically requests this deadline be extended to June 29, 2012, and the Respondent's deadline for filing its Reply to Supplemental Prehearing Exchange similarly be extended by one week to July 6, 2012.
