

**ORDER GRANTING JOINT MOTION FOR EXTENSION OF TIME**

By Joint Motion dated June 17, 2008, the parties moved for an extension of time to engage in the prehearing exchange.

The Motion is hereby, **GRANTED**, as set forth below:

Good cause exists for the granting of the Motion. The Motion indicates that the principals of the Respondent company are on currently travel and that Complainant's counsel has ear future extended vacation plans which circumstances are delaying the parties being able to meet to discuss settlement and/or properly prepare their prehearing exchanges. In that a hearing in this case has yet to be scheduled, no prejudice will result from a brief delay in the prehearing exchange process. Therefore, the deadlines established in the previously issued Prehearing Order are vacated and the following deadlines established: the parties are directed to engage in a settlement conference on or before **July 3, 2008**; Complainant shall file a status report regarding settlement on or before **July 10, 2008**; Complainant shall have until **August 15, 2008** to either file the fully executed Consent Agreement and Final Order or its initial prehearing exchange; Respondent shall have until **September 5, 2008** to submit its prehearing exchange; and Complainant shall have until **September 19, 2008** to submit its rebuttal prehearing exchange. All other requirement of the Prehearing Order remain in effect.
