

Respondent RBF Frozen Desserts LLC (“RBF”), by and through its undersigned counsel, pursuant to 40 C.F.R. § 22.7(b), respectfully moves for a 60-day extension of time file its answer to the Complaint and Notice of Opportunity for Hearing (“Complaint”) in the above-captioned matter. RBF’s answer is currently due to be filed on December 2, 2016. A 60-day extension would set a new filing deadline of January 31, 2017.

There is good cause for this extension request, as RBF and USEPA Region 1 counsel have had several conversations regarding the Complaint and are evaluating the possibility of resolving this matter through settlement. Counsel for USEPA Region 1 has indicated that the agency does not oppose this extension request.

WHEREFORE, RBF requests that this 60-day extension request be granted and  
January 31, 2017 be established as the deadline for RBF to file its answer to the Complaint.
