2. Pursuant to the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits, 40 C.F.R. § 22.14(d), Complainant may withdraw the complaint, or any part thereof, without prejudice one time before the answer has been filed.

3. On April 17, 2019, Complainant filed its Complaint in this matter.

5. Based upon Complainant’s recent investigation, it appears that further attempts to serve Respondent with this Complaint at the present time would be futile.


6. Respondent has to date not filed an answer to the Complaint.

7. Complainant has not previously filed any withdrawal of the Complaint, or any part


thereof, in this matter.


