**ORDER GRANTING JOINT MOTION FOR LEAVE TO AMEND COMPLAINT

On August 27, 2020, the parties in this matter filed a Joint Motion for Leave to Amend Complaint (“Joint Motion”) accompanied by an Amended Complaint removing Pilot Thomas Logistics, LLC as a party to this proceeding. Thereafter, on August 28, 2020, Respondent Thomas Petroleum, LLC, and Complainant filed a fully executed Consent Agreement and Final Order (“CAFO”) with the Regional Hearing Clerk for Region VI to resolve this matter. As the parties have demonstrated good cause to amend the Complaint, and this amendment is otherwise agreed upon, it is appropriate to grant the requested leave to amend the Complaint. Accordingly, the Joint Motion is **GRANTED**, and Pilot Thomas Logistics, LLC is hereby removed as a party to this proceeding. Further, as the remaining parties in this proceeding have resolved this matter through settlement with a fully executed CAFO, duly filed with the Regional Hearing Clerk for Region VI, this matter is hereby closed and removed from the docket.


