ADMINISTRATIVE PROCEEDINGS**


COMES NOW COMPLAINANT, the Director of the Compliance Assurance and Enforcement Division, United States Environmental Protection Agency (“EPA”), Region 6, by and through its attorney, who provides the following status report regarding the above-captioned proceeding and requests an extension regarding administrative proceedings:

1. On May 14, 2019, Complainant and Respondent reached an agreement in principle regarding this case. However, the agreement in principle must still be reviewed and approved by the Director of the Compliance Assurance and Enforcement Division (“Director”). It is the expectation of the Complainant’s attorney that the Director will approve the agreement in principle. Once approval is obtained from the Director, Complainant’s attorney will mail the proposed Consent Agreement and Final Order (“CAFO”) to Respondent for signature.

2. Complainant hereby requests an extension of administrative proceedings for 45 days to enable the Parties to obtain all the required approvals and signatures needed to finalize the CAFO. Complainant expects to file the CAFO within the requested 45-day extension period.

3. Complainant's attorney has discussed this status report and request for extension of administrative proceedings with Respondent's attorney, and Respondent's attorney concurs and does not object to the extension request.


