Rockydale Quarries Corporation**

Dear Mr. Randolph and Mr. Satterfield,

On May 14, 2019, the United States Environmental Protection Agency Region 3 (“EPA”) and Rockydale Quarries Corporation (“Rockydale”) entered into an Administrative Order on Consent, Docket No. CWA-03-2019-0053DN (“Order”, enclosed).

The Order required Rockydale, among other things, to conduct annual stormwater compliance audits regarding Rockydale’s compliance with its National Pollutant Discharge Elimination System (NPDES) permits and submit annual audit reports to the EPA for a period of five (5) years.

Based on the EPA’s review, the Respondent has complied with all actions required by the Order, and the EPA is therefore terminating the Order.

Please note, however, that any future noncompliance with the Clean Water Act (CWA), including repeated noncompliance, could result in the initiation of further review and action pursuant to the Federal enforcement provisions set forth in Section 309 of the CWA, 33 U.S.C. Section 1319.
