COMPLAINANT'S STATUS REPORT

Pursuant to Judge Susan Biro's Order Scheduling Hearing dated August 24, 2009, Complainant United States Environmental Protection Agency, Region 7 ("EPA") submits this Status Report in the above-referenced matter.

Attorneys for Respondent and Complainant held a phone conference on September 3, 2009. Respondent's attorney indicated that his client is still interested in settling this matter prior to the Hearing scheduled for January 12, 2010 and reiterated his client's assertion that they are unable to pay the proposed penalty.

Although Respondent has submitted tax forms for 2006 through 2008, it has failed to produce the required Ability to Pay form necessary for EPA to make a final determination on the inability to pay claim. This form was initially sent to Respondent's attorney on June 15th, 2009 and again on September 2, 2009. Respondent's attorney has repeatedly assured EPA that it would receive the form since June 22, 2009, but EPA has not yet received it. Although EPA has made some preliminary conclusions concerning Respondent's ability to pay based on their tax forms, EPA is unable to make a final determination without the Ability to Pay form. Once the form is received and EPA is able to make its determination, the parties will have a final penalty figure to discuss and may proceed with settlement of the present matter.
