



**MEMORANDUM IN SUPPORT OF RESPONDENT MASTER CONSTRUCTION CO.,
INC.'S MOTION TO RE-OPEN THE HEARING**

I. INTRODUCTION

This Memorandum is in support of a Motion to Re-Open the Hearing filed by Master Construction Co., Inc. (hereinafter "Master"), Respondent.

On or about July 9, 2009, the United States Environmental Protection Agency filed a Penalty Complaint and Notice of Opportunity for Hearing (the "Complaint") against 47th Street Townhomes, LLC, Jordahl Custom Homes, Inc., and Master. On or about May 13, 2010, a default initial decision and order was issued by the Court against Master for its failure to file an Answer pursuant to 40 C.F.R. §22.17. For the reasons set forth below, Respondent Master requests a ruling that the default initial decision and order for violation of §§ 301(a) and 402(p) of the Act, 33 USC §§ 1311(a) and 1342(p), for the period of April 28, 2008 to May 30, 2008 be vacated.

II. DEFAULT JUDGMENT STANDARD

A default judgment under 40 C.F.R. §22.17 is similar to default judgment under Rule 55 of the Federal Rules of Civil Procedure, and therefore case law thereunder is appropriate guidance as to default judgment. There is a strong judicial policy against

default judgments and preference for adjudication on the merits, which goes to the fundamental fairness of the adjudicatory process. See Oberstar v. F.D.I.C., F987 F.2d 494, 504 (8th Cir. 1993). The granting of a default judgment should be a rare judicial act. See Comiskey v. JFTJ Corp., 989 F.2d 1007, 1009 (8th Cir. 1993). Default judgment is only appropriate when there has been a clear record of delay or contumacious conduct. See Taylor v. City of Ballwin, Missouri, 859 F.2d 1330, 1332 (8th Cir. 1988)

III. ARGUMENT

In the EPA's Memorandum in Support of Complainant's Motion for Partial Accelerated Decision on Liability, the EPA made a motion to this Court to render a default order pursuant to 40 C.F.R. §22.17 on Master for its failure to file an Answer to its Complaint in which the Court ultimately issued. Although Master did not submit an answer to the EPA's Complaint, on or about January 28, 2009, Master submitted a response to the EPA's request for information, in which Master effectively made an appearance in this matter. In Master's response to the EPA's request for information, Master denied nearly every allegation set forth in the EPA's Complaint. A copy of Master Construction's Answer is attached hereto as Exhibit "A" and incorporated herein by reference. A copy of the United States Postal Service receipts evidencing that Master's response was in fact sent to the EPA is attached hereto as Exhibit "B" and incorporated herein by reference.

Although Master now acknowledges it did not file an answer within thirty (30) days as prescribed in 40 CFR §22.15, Master believed it had fully complied with the EPA's requests by submitting its January 28, 2009 response, and until May 27, 2010,

Master was unrepresented by counsel and therefore was unaware of the various requirements of Part 22 – Consolidated Rules of Practice, of which, very few licensed attorneys outside of the EPA have knowledge of.

The EPA filed its Complaint on July 9, 2009, however the EPA waited until April 8, 2010 to make its motion for default judgment, approximately 8 months later. The EPA clearly did not have any sense of urgency in filing its motion for default judgment, nor has the EPA indicated in any fashion that Master's failure to file an answer has prejudiced them in any way. The facts and circumstances relating to the allegations set forth by the EPA in its Complaint have not and will not change. The evidence will either prove or disprove Master's liability for the allegations set forth in the EPA's Complaint. Whatever the result may be, it should be determined based upon the evidence, not a set of procedural rules that only the EPA's legal counsel have a thorough knowledge of.

Default judgment under 40 C.F.R. § 22.17 is not an absolute right of the EPA's, rather it is granted at the discretion of the court, however, Master has a statutory right to demand a hearing. By upholding the default judgment against Master because of an immaterial deviation from the EPA's procedural rules, with no showing of prejudice to the EPA, the court would be unfairly depriving Master of its right to a statutorily mandated hearing.

IV. CONCLUSION

Because Respondent Master has made an appearance in the above-entitled matter, the EPA has not been prejudiced and Master is statutorily entitled to a hearing, default judgment pursuant to 40 CFR §22.17 is inappropriate and Respondent's Motion to Re-Open the Hearing pursuant to 40 CFR §22.28 should be granted.

Regarding the packet sent to Master Construction in late December requesting information pursuant to Section 308 of the Clean Water Act, 33 U.S.C. §1318, and Compliance Inspection Report, we feel it vitally important to clarify a gross misrepresentation as listed in the letter. Master Construction is not the owner of the construction site in question. We were hired as a subcontractor in April 2008 by Jordahl Custom Homes, the general contractor to install the site utilities for the 47th Street Townhomes. As a highway/heavy contractor we usually act as a prime contractor on many projects with the local cities of Fargo, ND, West Fargo, ND and Moorhead, MN. In each and every one of these contracts the owner pulls the stormwater permit and writes the SWPPP. Master Construction's responsibility as operator is to maintain the stormwater devices as required and indicated in the SWPPP only for the duration of the work we are performing. We are not privy to a large portion of the pertinent information that would be noted in the SWPPP and corresponding permit such as the legal description, description of existing soils, fill material and erodibility of such soils, the name of the receiving waters or Municipal Separate Storm Sewer System etc.

Master Construction completed the site utilities in late May/early June of 2008. First, our excavation operators came in and stripped the lot on the week of 4-28-08. Following that the underground crew came in on 5-5-08 and completed the installation of the water main, sanitary sewer and storm sewer by the end of May. We did not purchase any BMP's (Best Management Practices) specifically for this project. Master Construction always has a stock of the necessary items on hand. They are used and recycled on subsequent projects. Before placement on a new site they are all taken to our shop in north Fargo, cleaned and inspected, if they pass the inspection they are reused if not they are destroyed and new items are added. At the time that the crews entered the project site we set 4 bags in the inlets that were on 47th Street S between 47th and 48th Ave. Anytime there had been measurable

precipitation; namely 5-24-08 with .31" and 5-29-08 with .53" the bags were looked at by me, no problems or issues were reported at those times (exhibit #6). There was an existing silt fence on the north side of the project by the retention pond. We tied into existing utilities approximately 30' from the curb line as indicated on the attached drawing. The site itself was approximately 2 feet lower than the curb. The storm water manholes were sitting about 3 ½ feet above ground and we had plastic covering the manhole casting grates (see site map exhibit #7). There would have been a very negligible if any chance of erosion or drainage from the storm drains along 47th Street South into the City of Fargo MS4. All storm water management was monitored by me as well as on site by the utilities foreman, James Schlanser this was done on an as needed basis and no records were maintained. The construction of the townhomes and other work on the site by Jordahl Custom Homes continued throughout 2008 and will continue throughout 2009. From May 29 through July 7, 2008 we were again hired by Jordahl Custom Homes to import clay fill and place. This work was not part of the original proposal, but a service provided on a per hour basis as per the direction of Jordahl Custom Homes (see exhibit # 4). Payroll records for all work as described are enclosed (exhibit #5). As you can clearly see, when your inspectors were on site in October 2008 Master Construction had already completed the underground work and been off site for several months. From the moment we left the site all future erosion control measures would have been the responsibility of the next contractor, in this case Jordahl Custom Homes. Your inspectors report indicates that work began on approximately June 15, 2008. It was at that time that Jordahl Custom Homes' crews were on site for the actual construction of the townhomes. Master Construction was finished with their work as per the proposal, I have enclosed a copy of that proposal, our invoice for services to Jordahl and a copy of their check for payment in full (exhibit #1,2,3).

We do acknowledge that we should have been more persistent in getting a storm water permit from the owner prior to entering the site in April 2008, ensuring full compliance with the ND Dept of Health. However, even without it we were conducting all necessary storm water management as per our proposal with Jordahl Custom Homes. From early June forward the responsibility for the all storm water management would have fallen to the general contractor. At no time did we receive any calls from the Jordahl people looking for a storm water permit in order to transfer it to themselves, as they have indicated in the inspection report from October 2008.

We are not sure where you got the information that Master Construction was the owner of this site, but once again to reiterate, we are not. Jordahl Custom Homes the general contractor hired us as a subcontractor for the site utilities. We cannot answer the bulk of your questionnaire as we do not possess the pertinent information that would be needed to do so, other than the summation that I have provided here.

Dear Mr. Schlanser:

The Clean Water Act (Act) gives the United States Environmental Protection Agency (EPA) the responsibility to determine compliance with the Act and regulations and permits issued under the Act, in order to protect the Nation's waters from pollution. In furtherance of that responsibility, on September 23, 2008, EPA inspected the 47th Street Townhomes at 4696 47th Street South, in Fargo, North Dakota (the Site), which is owned and/or operated by Master Construction Co., Inc. and Jordahl Custom Homes, Inc.

This letter concerns the apparent failure to comply with the Act's requirements at the Site. Section 301 of the Act, 33 U.S.C. §1311, prohibits the discharge of pollutants to waters of the United States except as in compliance with section 402 of the Act, 33 U.S.C. §1342, among CWA provisions.

This letter also includes the report for the September 23, 2008 inspection. Please note that prior to the inspection, EPA inspectors presented credentials and informed the facility of the inspection process. Following the inspection, the EPA inspectors conducted an exit interview where they discussed their observations with representatives from Jordahl Custom Homes, Inc.

As part of its investigation of these apparent violations of sections 301 and 402 of the Act, the EPA is authorized to request information pursuant to section 308 of the Act, 33 U.S.C. § 1318. Please provide the information requested below for the Site as clearly and completely as possible **within thirty (30) calendar days** of your receipt of this letter to Amy Clark (8ENF-W-

NP) at the letterhead address above. Respond to each request to the fullest extent possible. If you cannot respond to a specific question, please provide an explanation as to why you can not answer. If information or documents become known to you after you send your reply, forward the newly found information as soon as possible.

The accuracy and completeness of the responses and documents required must be certified. A sample certification statement is enclosed. For a corporation, partnership, or sole proprietorship, the individual signing the certification must be a responsible corporate officer, general partner, or the proprietor, respectively.


A Small Business Regulatory Enforcement and Fairness Act (SBREFA) information sheet containing information on compliance assistance resources and tools available to small businesses, is enclosed with this letter. The inclusion of this information sheet does not necessarily mean that EPA has determined that your organization is a small business. 


