If Complainant chooses to file an amended complaint, Respondent shall have 20 additional days from the date of service of the amended complaint to file its answer in accordance with section 22.14(c) of the Consolidated Rules, but in no case shall Respondent be required to answer an amended complaint before February 13, 2008.
