## Dear Madame/Sir:

On October 1, 2010, the US Environmental Protection Agency (EPA) issued an Emergency Administrative Order (Order), Docket No. SDWA-08-2011-0001, to General Chemical Industrial Products (the Company), as owner and/or operator of the General Chemical public water system (System). EPA understands that the Company is now known as Tata Chemicals North America, Inc. This Order instructed the Company to address a situation which may have posed an imminent and substantial endangerment to the health of persons served by the public water system under the Safe Drinking Water Act (SDWA), and was issued pursuant to EPA's authority set forth at section 1431 of the SDWA, 42 U.S.C. § 300i.

Our records indicate that the Company is in violation of the Emergency Administrative Order and its Addendum issued on December 15, 2010. Among other things, the December 15, 2010, Addendum included the following requirements (quoted from the schedule table on pages 1 and 2 of the Addendum):

 Action: Schedule hydro-vac truck for excavation; examine lines and valves. Completion date: May 30, 2011 – June 17, 2011.

On August 12, 2011, Lee Bruder of Tata Chemicals (Soda Ash) Partners advised EPA by e-mail that work by hydro-vac contractors had not yet begun.

 Action: Order required parts and complete repairs. Completion date: June 22 – July 22, 2011. In the same e-mail of August 12, 2011, Tata Chemicals (Soda Ash) Partners advised EPA that valves required for the overall project had taken longer to acquire than anticipated and that the repair project had not yet been completed. Via a separate e-mail on August 19, EPA inquired as to when project completion was anticipated given the difficulties reported, but no additional information has been forthcoming.

Please notify EPA immediately about the current status of the work noted above. In accordance with paragraph 15 on page 5 of the Order, the Company is required to submit written monthly reports to EPA on the status of all corrective measures. Further, in accordance with paragraph 16 on page 5 of the Order, the Company is required to notify EPA within 10 calendar days of completion of the tasks outlined in the Order's Addendum.

EPA is considering additional enforcement action as a result of the non-compliance with the Order detailed above. Violating an Emergency Administrative Order may lead to civil penalties of up to \$16,500 per day.
